## \* INFORMATIVE CLAUSES OF DATA PROTECTION\*

- ✓ Bilbao Exhibition Centre, S.A. ('BEC') with registered address in Ronda de Azkue 1, 48902 Ansio-Barakaldo are co-responsible for the processing of your personal data. For these effects, they are committed to collaborate in good faith to guarantee compliance with the obligations established in the field of data protection and, more specifically, to fulfil the exercise of your rights in compliance with the conditions established in this policy.
- ✓ The purposes of the processing of your data by BEC are (i) managing your participation in SUBCONTRATACION and the contractual relationship that is generated as a result of your participation as an exhibitor, and (ii) keeping you informed of future events related to the sector that may be of interest to you.
- ✓ The personal data provided will be held by BEC until the termination of the legal relationship that resulted of your participation, or, where appropriate, until you exercise your right of opposition to the purpose (ii). As of this time, BEC may store your data, even blocked data, for a period of six years or for the limitation period of actions related to its responsibilities, when this period is in excess of the afore mentioned.
- ✓ The legal grounds for the processing of your data is for purpose (i) the implementation of the legal relationship between BEC as organizer and you, as an exhibitor, and for the purpose (ii) the legitimate interest of BEC, consisting respectively of raising awareness of events held at BEC, related to the sector, that may be of interest to the recipient.
